Concessions:

- Had a great MAPS show and almost sold out of stock.

Fundraising:

- Bag Bingo raised about $\$ 4000.00$
- Sweet Ashley's candy sale raised $\$ 219.00$ for SPAs and $\$ 146.00$ for SFMA
- Bruster's was a the MAPS show and brought in $\$ 264.00$
- The flower sale is going on and orders are due by April $24^{\text {th. }}$ Pick-up will be on May $11^{\text {th }}$ from 6:00pm-8:00pm at Coach McNelly Stadium. A Sign-Up Genius will go out asking for volunteers to help with distribution.
- Trivia night is May $5^{\text {th }}$ and we still need help collecting items for prize baskets. Tickets will be on sale this week.
- Raise Right:

March was much better than February with $\$ 11,000.00$ in purchases.
The average monthly rebate is $3 \%$, and March's was $5 \%$
$\$ 253.00$ was earned for SPAs and $\$ 214.00$ for SFMA
Monthly tips and reminders will go out.

Hospitality:

- Provided a meal for percussion at the Monroe Township WGI Regionals and are working on snack and meals for the Dayton trip.

Ram Crew:

- In May a request for help will go out, the away concessions stand needs to be cleaned out and a lot of the items moved to the new Ram Shack
- The mule will need to be serviced this summer; President recommended setting that up ASAP

Data/Membership:

- We had 4 new members
- Data- Keeping up with reporting online orders and payments.

Uniforms/Merchandise:

- Band uniforms are being worn on Memorial Day.
- Will need help with taking uniforms to and from cleaners (Asking District to pay for cleaning)
- Merch-Sold out of a lot of inventory; did well at the Strings Jamboree
- Looking for a new merchandise distributor
- Looking for volunteers to help with merchandise


## New Business:

- Welcome to the new HS band director, Mr. Andrew Walls! We are looking forward to working with him and supporting him in any way we can as he takes on his new position.
- Nominations are due by May $2^{\text {nd }}$ and the election will take place at the member meeting on May $9^{\text {th }}$. Board seats for President, Assistant Treasurer and Secretary are up for election. The nominations can be submitted to the Nominating Committee: Lauren Chychota, Scott Houde and Beckie Landry.
- An amendment to the By-laws to accept absentee ballots would need to be discussed in an executive meeting and then voted on by the general membership. For this reason, any such amendment would not be effective for the upcoming election.
- SFMA provides food for the Teacher Appreciation Breakfasts at the 10-12 and $9^{\text {th }}$ Grade Centers. This year, it they will be held on May $9^{\text {th }}$. A Sign-up Genius will go out asking for volunteers to set up at each school.


## Old Business:

- MAPS Show-Overall, we brought in over 20,000.00 from ticket sales, concessions, candy grams, etc. SFMA keeps half of the ticket money and donations to concessions and hospitality keeps our costs low.
- Feedback from MAPS show:

We need better internet and WiFi so the card readers for payments.

Some groups did not like using the orchestra room for their warm-up. The lack of classrooms available for use is due to teacher complaints in previous years that the rooms were damaged while the groups were in them.

Several people mentioned that our school had the best facilities anywhere.
